Business Response Update (20.04.2020)

As part of our commitment to our employees, delegates and clients and in line with the British Government announcement made on the 23rd March 2020, during these unprecedented times and in order for our employees to perform safely, JNC Safety Services Limited business remains operational however, we have restricted some of the services we can currently offer which are detailed below.

JNC Safety Services Limited - Restricted Services updated as at 20.04.2020:

Training

Due to the spread of COVID19 and current restrictions in place we have made the decision to pause all face to face training during April, May and June 2020. The rationale behind this decision has been based on the definition of 'essential' and the continued risk of spread.

We will, therefore, be making contact over the next 72 hours, for anyone currently booked on an upcoming course, to transfer your booking to a later date. Whilst this is exceptionally difficult and no doubt disappointing to some, we feel this course of action is necessary.

If you have a CITB Site Management or Supervisor Safety Certification that is due to expire or has expired since 15th March 2020 then CITB have confirmed you will still be able to complete a refresher course at the next available date. This will remain in place whilst the current COVID19 situation continues and will be reviewed on a regular basis.

Site Inspections / Visits

As travel continues to be restricted to 'essential' by the British Government we will not be attending 'general' site inspections / visits until the restriction has been lifted. Obviously we appreciate the safety of our clients is paramount and we will be making contact to individual clients to discuss ways forward during this difficult time.

Where a site visit / inspection is absolutely necessary this can still be undertaken with prior agreement and only then with appropriate risk assessments being undertaken in advance. If we are unable to do this safely then an option would be via a video conference call.

We will continue to monitor the situation and update accordingly. Thankfully to date the health of our employees has not been directly affected by COVID19.
